## **General Information**



#### How to get to the Senedd

**Bus:** The No. 6 Baycar leaves from Cardiff Queen Street Station, Dumfries Place, Greyfriars Road, St. Mary Street or Cardiff Central Railway Station every 10 minutes and stops at both Pierhead Street and outside the Wales Millennium Centre adjacent to the Senedd.

Routes 7 and 8 depart from Canal Street and Westgate Street respectively every 15 minutes and stop on Pierhead Street, a short walk (approximately 200 metres) from the Senedd, Tŷ Hywel and the Pierhead building.

**Train:** Services run every 12 minutes from Cardiff Queen Street Station to Cardiff Bay Station. The station is a few minutes walk from the Senedd, Tŷ Hywel and the Pierhead building.

**Road:** From the West, leave the M4 at junction 33, follow the A4232 to Cardiff Bay and follow signposts to National Assembly for Wales, CF99 1NA.

From the East, leave the M4 at Junction 29, follow the A48 and then A4232 to Cardiff Bay and follow sign posts to National Assembly for Wales, CF99 1NA

**Car parking:** The nearest car park is the Q-Park multi-storey on Pierhead Street, a short walk from the Senedd. On-street, pay and display parking may be available on Harbour Drive or there is a pay and display car park off Stuart Street. TEST

**Disabled car parking:** Parking is available by prior arrangement for visitors to the Assembly who are disabled. There is an external lift available for visitors who are disabled at our accessible parking area outside the Senedd. A minimum of 24 hours' notice is usually required together with information about the vehicle and driver. Visitors must display their disabled parking badge on arrival.

**Bike / foot:** The Taff Trail, which runs from Brecon along the River Taff through Cardiff city centre to Cardiff Bay, ends at the Oval Basin outside the Senedd. There is also a cycle and footpath, which runs along the A4232 from the Cardiff Bay Retail Park.

**Taxi:** A number of firms provide taxi services from Cardiff city centre to Cardiff Bay. Taxi ranks are situated across the city, including outside Cardiff Central railway station, near St David's Hall and at the bottom of Park Place.

**Assistance and medical help:** If you have any concerns during the day either speak to one of the stewards or someone in the registration area and you will be directed to the relevant staff. First Aid assistance will be available throughout the day.

Security: There is a cloakroom facility for public use in the scanner area on Assembly sitting days.

**Mobile Phones:** As a courtesy to speakers and other delegates, please ensure that all personal mobile devices are 'on silent' or are switched off during the events.

#### **Dr. Daniel Baker**

Daniel Baker is a Romani Gypsy born in Kent, United Kingdom in 1961. An artist, curator and theorist, he holds a PhD on the subject of Gypsy aesthetics from the Royal College of Art, London. Baker is curator of FUTUROMA at the 58th International Art Exhibition at the Venice Biennale 2019. He acted as exhibitor and advisor to the first and second Roma Pavilions: Paradise Lost and Call the Witness at the 52nd and 54th Venice Biennales respectively. Baker's work examines the role of art in the enactment of social agency through an eclectic practice that interrogates contemporary art discourse and its social implications via the reconfiguration of elements of the Roma aesthetic. Baker acted as Visual Advisor to the RomArchive: international digital archive of Roma arts. His interest in Gypsy visuality was sparked by his research into the experience of Gay Romani men in the UK carried out for his MA dissertation titled 'The Queer Gypsy' which was subsequently published by the ERRC. Publications include We Roma: A Critical Reader in Contemporary Art (2013) and Ex Libris (2009). Baker's work is exhibited internationally and can be found in collections worldwide. Former Chair of the Gypsy Council (2006–2009). He lives and works in London: www.danielbaker.net

#### **William Bila**

William Bila was born in New York City the son of Czechoslovak refugees fleeing the Soviet invasion of the Prague Spring. He discovered his Romani heritage in late childhood. As the product of a multicultural North American upbringing, he has always been proud and curious about his roots. The turning point for his activism, which started in the 1990s, came when he moved to Canada and joined the Roma Community Centre in Toronto during the autumn of 2008. Ever since, he has remained engaged with a variety of organizations in support of Romani culture, education, history, and rights themes. He has served in several volunteer positions such as, President of La Voix des Rroms (France), member of the board of Roma Education Fund (Switzerland), Roma Education Support Trust (UK) and the Center for Intersectional Justice (Germany). He also took part in the first and second ever European LGBTIQ Roma conferences in Prague (2015; 2016). Among his pioneering career adventures, he participated in the pilot implementation of a worldwide diversity policy at a global financial services provider based in Germany, supporting LGBTIQ+ rights in the workplace. With over 25 years of experience in corporate consulting, strategy and human resource roles, his most recent endeavors as a freelance consultant include managing the on-line communications of the Berlin based RomArchive project, advising the European Roma Rights Center partnerships and network development, and serving as a guest lecturer for Chicago based DePaul University's study abroad program in Berlin. He is a proud member of ACERT and a supporter of the Romani Cultural and Arts Company of Wales.

#### Isaac Blake - Director - Romani Cultural & Arts Company, Cardiff

Isaac Blake is a proud Gay Romani Gypsy and has worked as a professional dancer and choreographer. He is currently Executive Director of the Romani Cultural & Arts Company in Cardiff, UK, which is funded by a variety of major funders and government departments. As



Executive Director of the Romani Cultural & Arts Company (RCAC), Isaac has developed arts and performance programmes on Gypsy and Traveller caravan sites with young children and adults, worked in schools and colleges, and promoted arts as a medium for empowerment and advocacy throughout Wales with Gypsy, Roma and Travellers. He has engaged widely with non-Gypsy communities to promote dialogue and improve social cohesion. His leadership and management of the RCAC has seen the organisation grow from a small voluntary group to a major third sector (NGO) agency that leads the Romani and Traveller field in Wales and is one of the major players in Romani and Traveller advocacy and empowerment in the UK. RCAC is now celebrating its 10th anniversary. Isaac has also been a Dance Curator, leading a team of academics and researchers in collating appropriate items and artefacts for the RomArchive. The RomArchive was devised as an international digital archive for art of the Roma, and remains a constantly growing collection of art of all types, complemented by historical documents and scholarly texts. Isaac has been instrumental in supporting LGBTQI rights in UK, Europe and beyond, particularly with respect to the Gypsy, Roma & Traveller communities. Isaac has supported LGBTQI Gypsy, Roma & Travellers to attend events internationally and Isaac has personally attended such events to be an advocate and representative of his community and to positively promote LGBTQI.

## Martin Campbell - Director of the Gypsy Roma Traveller Police Association

Martin Campbell is the Director of the Gypsy Roma Traveller Police Association, an association set up primarily to support Police Officers and Staff who are from Gypsy Roma and Traveller communities of the UK and Europe. Martin is a Gypsy from the North West of England who is currently serving as a Police Inspector. He has worked in Emergency response, Proactive Crime Squads, Community Policing, CID and various other departments during his 13 years of Service. Martin has been involved in the GRTPA since its creation in 2014 serving as a Director in 2016 and again in 2018 and 2019. Martin has been fighting for fair and equal treatment for GRT communities across the UK and Europe. This has included participation in initiatives in Ukraine and Europe to improve the security of Roma Communities, Challenging in Parliament Police Units (now disbanded) and numerous public speaking events to raise awareness of Suicide, infant mortality and discrimination in GRT communities. "People often ask me why I am involved in challenging Police and other ministry of justice agencies publically when I am in the role of Director to support Officers & staff. My answer is always that discrimination against GRT communities is prevalent within these organisations and this isolates victims from within the community discouraging them from seeking help and support they are entitled to. A combination of frequent & disproportionate Police response and lack of community engagement reduces a fragile state of police legitimacy in the community. We must be part of the Policing community if we want to improve this. My association can support Officers and Staff, we have been doing it since 2014 since our founding members Jim and Petr broke the mould, what I want to do now is ensure future generations of all GRT communities feel that the police of the UK is not only a career option but also an attractive option."



## Jane Hutt AM, Deputy Minister and Chief Whip – Welsh Government

Jane spent part of her childhood in Uganda and Kenya, and was educated at the University of Kent, the London School of Economics and Bristol University. She has lived and worked in Wales since 1972. Jane was an elected member of the former South Glamorgan County Council for 12 years and was first elected to the Assembly in 1999. Between 1999 and 2005 she served as Minister for Health and Social Services in the Welsh Government. From 2005 to 2007, she was Minister for Assembly Business and Chief Whip. In the first Cabinet of the Third Assembly she was appointed Minister for Budget and Assembly Business. In the coalition Cabinet, announced on 19 July 2007, she became Minister for Children, Education, Lifelong Learning and Skills. In December 2009 she was appointed Minister for Business and Budget, subsequently Minister for Finance until 2016 when she was appointed Leader of the House and Chief Whip at the start of the Fifth Assembly. On 13 December 2018 Jane was appointed Deputy Minister and Chief Whip. Jane Hutt is an honorary fellow of Cardiff Metropolitan University and Cardiff and Vale College. She is a Welsh learner.

#### Vera Kurtic

Vera Kurtic is a proud feminist and a Romani woman. She studied sociology and communications and for many years has been an activist for Roma, LGBT, animal and women's rights. She is currently the Project Officer in Belgrade working in the Council of Europe Roma and Travellers Team within the Programme ROMACTED -'Promoting good governance and Roma empowerment at local level'. In her research, Vera mainly focuses on intersectionality of gender, race, nation, class and minority sexual existence. In her book Džuvljarke-Roma Lesbian Existence, Vera tackled the problem of the invisibility of Roma lesbians who are denied their own identities, achieved relations and personal connections, both within the Roma and broader social communities. Vera enjoys veganism, writing short stories and photography.



### **Chris Lee**

Chris Lee grew up in north Wales. Chris is openly gay, a feminist and proud of her Romani heritage. She trained as a Graphic Designer specifically in the area of media design and design aesthetics and has worked in theatre, advertising and education. Chris ran her own graphic design company Chris Lee Design for 15 years. Chris Lee is a Community Champion for the Romani Cultural and Arts Company in Cardiff. The RCAC is the only organisation of its kind in the UK which is run entirely by individuals of Romani Gypsy heritage. She is involved in a wide range of work with the RCAC including participating in training days throughout Wales covering the history and culture of Romani Gypsies and Roma, Traveller accommodation, health, education and racism. In 2016/2017 she was part of a team who over the course of a year, carried out groundbreaking work interviewing Traveller families throughout Wales about their health and wellness. This was the first project of its kind to be undertaken in the UK. The team of 6 researchers recorded important first hand oral testimony from Travellers themselves about their health and their experiences of accessing health care in all parts of Wales. This research is now acting as a foundation to bring about real change. She attended the first International Roma LGBTQI Conferences in Prague in 2015 and 2016. Both of these events were organised by Roma activist David Tiser and his ARAART team. Participants in these conferences and subsequent meetings are creating a Roma LGBTQI 'movement' throughout Europe.

#### **Dezso Mate**

Dezso Mate is currently the Consultant of the Open Society Foundations Community Youth Fellowship, which focuses on the Roma LGBTQIA intersectional challenges in public healthcare settings. The programme is supported by the Youth Exchange and Public Health Programme. The Programme's clear aim is to give a voice to voiceless people. Dezso is also working on his PhD at the Eotvos Lorand University of Budapest. Dezso has studied in the University of Pecs in Hungary and also in Eindhoven. In 2013 he was a Junior Research Fellow in the Hungarian Academy of Sciences. Dezso's research interests focus on the intersection between the Roma and LGBTQ Community; the generational change of Roma graduates; the impact of social resilience; segregation, disability and the 'labelling' of Roma children in education. Dezso has also worked in the Equal Treatment Authority in Hungary and taught in several schools in disadvantaged areas where he supported Romani children. Dezso's mother died when he was 6 years old. His father kidnapped him and his father was later arrested. Dezso Mate was homeless for years. He started his education at the age of 9. Dezso now lives in a happy relationship with his same-sex husband. He is proud of his intersectional identity as a Romani Gay scholar.

# queer + Roma = wonderful



QRTV Europa is an entertainment, cultural, lifestyle and music channel. Its mission is to bring the various European communities closer to each other and to help the European human rights movements, activists and NGOs to create more inclusive societies, a fairer and more equal future.

## Why QR'

QR is our abbreviation of QueeR, because our content highly features queer and LGBTQI cultures and people (as a less-represented group in the mainstream media). At the same time, we believe that on QRTV everyone can find useful, entertaining and informative content The abbreviation QR mainly efers to a multi-marginalized group of Europe, Queer Roma, broadly speaking, to the Roma LGBTQI people to whom we ourselves, the initiators, belong or are connected.

# QRTV is a TV Channel with Queer Roma identity.
